SELECTMEN MEETING MINUTES

March 16, 2017

- **Attendance:** Selectmen –Emil Braley, Jeff Amatrudo and Debra Black
- Residents and Guest –Willard Boothby, Kevin Wormwood, Ruth Adams, and Roxanne Herrick.
- **Selectman Braley called the meeting to order at 7:01 p.m.**
- **Selectmen Minutes:** Selectman Amatrudo made a motion to approve the Selectmen’s Meeting minutes of March 9, 2017 as written, second by Selectman Black and vote unanimous.
- **Approval of Warrant # 11:** Selectman Amatrudo made a motion to approve Warrant #11 as published: Appropriations: \$24,088.01 - Payroll: \$8,974.91 for a total of \$33,062.92, second by Selectman Black and vote unanimous.

Purchase Order Requests:

- **Snow & Ice:** Selectman Braley read the following purchase order requests: a request to purchase 4 cutting edges for the loader from Nortrax for \$660.54; a request to purchase bulbs, washers, bolts, threaded hose and cutting tips for \$105.94; a request to pay Morton Salt \$2,082.00 for 33 tons of salt; a request to reimburse Emil Braley \$18.17 for bolts and washers for truck 6; a request to pay White Bradstreet \$525.00 for one bell housing for truck 6; a request to pay Eastman Welding \$120.30 for piping to build three wing arms; and a request to pay Sanel Auto Parts \$270.00 for hyd. hose and fittings. Selectman Amatrudo made a motion to approve the purchase orders for Snow & Ice, second by Selectman Black and vote unanimous.
- **Limington Youth League:** Selectman Amatrudo made a motion to approve a request to pay the yearly website fee of \$299.40 from League Pro Inc., second by Selectman Black and vote unanimous.
- **Code Enforcement:** Selectman Amatrudo made a motion to approve a request to pay Main-Land Development \$20.00 for CEO training, second by Selectman Black and vote unanimous.
- **Fire/EMS Dept.:** Selectman Amatrudo made a motion to approve a request to pay Coastal T Shirt \$30.00 for lettering 2 new jackets, second by Selectman Black and vote unanimous.
- **Parade:** Selectman Amatrudo made a motion to approve a request to reimburse Beverly Foss \$19.60 for two books of stamps, second by Selectman Black and vote unanimous.
