 - -Discussed future revaluation of properties & cost of that operation
 - Capital Improvements: assessment of Town Hall needs & expansion(s), Fire & EMS; when to allocate funds for required assessment & engineering studies; working Fire/EMS building, & & municipal building, into the 5 -year plan. It was recommended that Fire/EMS revenues be directed into Fire/EMS Capital Improvements.

Human Services, \$30,830: FAC: 5 yes, none opposed, 1 absent/SB: 3 yes, none opposed.

Public Safety, \$1,129,861: FAC: 5 yes, none opposed, 1 absent/ SB: 2 yes, none opposed, 1 abstention.

Roads & Highways, \$1,590,048: FAC: 4 yes, 1 abstention, 1 absent/SB: 2 yes, none opposed, 1 abstention.

Sanitation, \$541,583: FAC: 5 yes, none opposed, 1 absent/SB: 3 yes, none opposed.

Leisure Services (Recreation), \$406,116: FAC: 4 yes, none opposed, 1 abstention, 1 absent/ SB: 3 yes, none opposed.

Capital Improvements:

LP&R, \$40,000: FAC: 4 yes, none opposed, 1 abstention, 1 absent/SB: 2 yes, none opposed, 1 abstention.

Fire & EMS, \$400,000: FAC: 4 yes, none opposed, 1 abstention, 1 absent/ SB: 2 yes, none opposed, 1 abstention.
