**Transfer Station hours** are Saturday and Sunday from 9 a.m. to 4 p.m. and Wednesday 12-4 p.m. **A Transfer Station sticker must be attached to your vehicle windshield for the disposal of ALL items.** 

**Trash collection:** The regular schedule has begun: If your trash day was Tuesday, it will most likely become Monday, if your trash day was Thursday, it will most likely become Wednesday. The Town appreciates your patience while the routes are fine tuned. As an example, Shaving Hill Rd is now on Mondays.

**General Assistance Office** is open on Tuesdays from 3-5 p.m. Applications are available anytime from the Town Clerks office during their normal business hours. Applications must be filled out and accompanied with supporting documentation and must be signed.

**Planning Board** meets at the Municipal Complex on site the first and third Monday evenings at 7pm. The next Planning Board meeting is July 18, 2022, and there is a Public Hearing on Gravel Pit eextraction.

The Old Town Hall Committee meets the first Tuesday of the month at 7 pm.

**Limington Parks & Recreation** holds their meetings the second Thursday of the month after the Select Board Meeting.

## **Open to the Public:**

**Susie Hanley:** OTH Preservation Society has two raffles in process, to be drawn at the September 6, 2022 meeting. An afghan made by a community member is on display at the Davis Memorial Library. The library has graciously agreed to help with ticket sales. The second item is two cord of seasoned firewood, donated by Skip Murray, to be delivered within a 20 mile radius of Limington. Tickets can be purchased from any board member, or at the library.

Stanley Hackett reminded Susie that Town employees and committee members are not to participate.

**Donna Sawyer:** Would like to recognize and thank 4 heroes from the rescue call at there home on Tuesday July 12, 2022: Bob Munson, Ethan Norcross, Emil Braley, and Dawn McAllister, for their professionalism and kindness in transporting her husband, who she says is alive due to their diligence.

Donna also asked Stanley why he opposes the Extraction Ordinance, Stanley Hackett replied that it is redundant, costly, difficult to enforce, and the State already monitors so why are we doing it again. Jonathan Kinney pointed out that the Extraction Ordinance will be discussed at the Planning Board meeting Public Hearing.

Donna also discussed the trash and lack of clarity of pick up days. The Town asks for patience while the routes are fine tuned.

Donna asked about the new fees and how it applies to the Planning Board, Jonathan Kinney and Stanley Hackett both said that this is only for Code Enforcement fees, not Planning Board and the Planning Board has done a good job updating their fees.
