Conversation about access and right of way to cell towers and that the cell phone companies need to be able to repair and upgrade equipment.

## Weekly Update on Select Board activities:

PWD update: on truck bodies are on order so we have them when the chassis are purchased, the striping machine is being purchased using ARPA funds because it is for Public Safety such as road striping, parking lots, and the Parks \& Rec department. One of the new trailers are on order. Transfer Station: tire costs ( $\$ 5.00$ ea charge to town for pick up, and a $15 \%$ fuel charge. We have explored other option, but they are very limited) weekly pickups, additional empty container possibility? The Transfer Station does not accept commercial trash, businesses in town must provide there own trash removal.
Fire/Ems May 17-21 is EMS week.
Parks \& Rec: track and T-Ball, pokemon club (5pm-6pm on Wednesdays through the end of April), OTH trash disposal when the programs begin. Discussed the Limington Academy gym and well and the possibility of discussions with the trustees and well association. The MMDY pavilion dedication is in the works for the beautiful building at the beach. There will be a public hearing date announced prior to the town accepting the building.
After April 13, 2023 MSAD\#6 will be presenting the school budge, which currently looks to be $\$ 4,175,452$ the town of Limington's portion, which is up approximately $8.07 \%$ from 2023 . We encourage the public to attend and we will announce when the presentation will be.

Working on reactivating the Comprehensive Plan Committee to update the Town's plan as required by LD2003 by July 1, 2023.
