Old & New Business:

Motion to change the rates for tires at the Transfer Station from \$2.00 to \$6.00 per passenger tire, larger tires at \$21.00.

Tires recycling prices have gone up from \$1.50 per passenger tire and \$8.00 for larger tires and we must accommodate. We will be researching a new carrier to see if we can cut these costs, but at this time w must raise the prices.

Motion to accept the new tire fees affective immediately at the Transfer Station as written made by Stanley Hackett second by Michael Barden approved.

Weekly Update on Select Board activities:

Regarding the Saco River TV and changes to our video: the system we have is outdated and not compatible with HD requiring new cameras, microphones, and wring to allow us to improve our broadcasting and be more easily understood for broadcasts and inhouse meetings.

Select board continues to work on abatements and veteran's exemptions.

Spoke with Joyce Foley about LD2003: this took away local control of growth & permits, deals with setback changes. The wording says the town "must" comply, however LD2003 is currently being challenged. The Town would like to have an article on the March Ballot addressing this as it is difficult with wells and private septic systems to allow he unlimited growth the bill seeks. We will share more details as they are available.

GWI sent an email to the Board requesting a letter to see about a grant for running broad band cable to our area. This would be no cost to the Town, and the Town will support the efforts by GWI.

Stanley Hackett has agreed to be our representative in contact with MMA in researching low income housing for the area. Due to the growth in town, this will be an issue o be addressed in the future.

In a continued effort to streamline our offices, iWorq is now LIVE for electronic building permit, electrical permits and plumbing permit applications on the Town of Limington web page.

Transfer Station hours are Saturday and Sunday from 9 a.m. to 4 p.m. and Wednesday 12-4 p.m. **A Transfer Station sticker must be attached to your vehicle windshield for the disposal of ALL items.**

General Assistance Office is open on Tuesdays from 3-5 p.m. Applications are available anytime from the Town Clerks office during their normal business hours. Applications must be filled out and accompanied with supporting documentation and must be signed.

Planning Board meets at the Municipal Complex on site the first and third Monday evenings at 7pm. The next meeting is October 24, 2022. There will be a public hearing Wednesday November 09, 2022.

The Old Town Hall Committee meets the first Tuesday of the month at 7 pm.
